Summary of Forum Breakout Sessions

Forum participants will have two opportunities to gain skills and knowledge in areas of their choosing. Below are brief descriptions of the sessions.

1. The Fundamentals of Evaluation for Community-Academic Partnerships and Projects

This first session on Evaluation will cover the basics in evaluation for community-academic partnerships and projects. Topics will include: the elements of evaluation; a description of Community-Based Participatory Approach (CBPA) in evaluation; and detailed examples of CBPA to evaluation.

2. Community -Academic Research Partnerships: Successes, Challenges, and Reflections – Finding a Partner

For this session, we invite academics and community members to bring potential research ideas. You will hear from other faculty members and Community-based organizations (CBOs) who will share their experiences. There are unique issues for both community and those in academic institutions as they engage as partners in research. Hear about their lessons learned. This is a networking opportunity for potential research partners for your project – or to share your research ideas to be matched with an interested partner at some point in the future.

3. Using "Big Data" to Analyze Health Disparities (Part 1 and Part 2)

We are in an unprecedented era science and research where the use of "Big data" is becoming increasingly important in enabling new directions for biomedical research and healthcare. What is "Big data"? and what role can it play in addressing health disparities? In this session, the scientists will bring these critical questions to life and engage the audience in a very lively discussion. With research interests in informatics, genomics and personalized medicine, diabetes, and hypertension, and physical activity, presenters will introduce participants to the concept of "big data" share how "big data" biomedical informatics, analytics and technology can potentially help to address health disparities. Bring your questions and concerns about "big data" and research – and ask the scientists.

4. Evaluation: Building the Evidence to Demonstrate Impacts and Outcomes

This second session on Evaluation will build on the basics from the first session. During the session, faculty will: discuss evaluation planning and design considerations; describe the tools and methods for qualitative and quantitative data collection and analysis; and, discuss dissemination and lessons learned.
