

## Student Aid Portion (a)(1)

- (1) An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.**

Morehouse School of Medicine signed the Federal Funding Certification and Agreement on April 13, 2020. MSM intends to use no less than 50 percent of the funds received under Section 18004(a)(1) of the Cares Act to provide Emergency Financial Aid Grants to students.

- (2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

The total awarded by the U.S. Department of Education through 12/31/21 is \$325,558.

- (3) The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (*i.e.*, as of the initial report and every calendar quarter thereafter).**

The total distributed for the quarter 10/1/21 – 12/31/21 is \$16,368.95. This is for the CRRSAA (a)(1) program.

The total distributed from inception through 12/31/21 is \$92,180.95. This is for the CRRSAA (a)(1) program.

**(4) The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

The estimated total number of students eligible to receive Emergency Financial Aid Grants under the CRRSAA (a)(1) program is 1,554. This is the number for inception through 12/31/21.

The estimated total number of students eligible to receive Emergency Financial Aid Grants under the CRRSAA (a)(1) program is 143. This is the number for the quarterly period 10/1/21 - 12/31/21.

**(5) The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

The total number of students who have received an Emergency Financial Aid Grant under the CRRSAA(a)(1) is 70. This is inception through 12/31/21.

The total number of students for the quarter 10/1/21 – 12/31/21 is 17.

**(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

Students who were eligible for financial aid and demonstrate an exceptional financial need can be considered for the student portion of the CRRSAA grant as a result of the pandemic. Acceptable documentation included expenses based on the cost of attendance that included technology, health care, childcare, course materials, rent, food, or other related expenses. The institution used the grant limits for the student federal aid from our existing emergency loan program reducing it to \$750 per student to maximize the number of students who would receive the grant. We then increased the student federal aid amount to \$1,000 limit after the first round consistent with our emergency loan limits to assist students with exceptional financial needs as it relates to the pandemic.

**(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.**

There is an application for students to complete. We also provide students the Q and A regarding the Cares Act regulations and provided links where they could go directly to the DOE for additional information. Eligibility Requirements

We must meet be able to verify the following requirements:

- Completed a FAFSA for 2019-2020
- Enrolled for Spring 2020 at least 6 hours for the semester
- Must be maintaining Satisfactory Academic Progress during Spring 2020
- Must be a citizen or eligible non-citizen
- Must not be in Default of any Federal loan
- Cannot be enrolled in a completely on-line program (per Federal regulations)
