# The Louis C. Brown Vanguard Award

In 2009, Morehouse School of Medicine established the Louis C. Brown Vanguard Award. The award is named in honor of the late Atlanta internist and a founder of MSM. The Vanguard Award recognizes individuals whose pioneering spirit and demonstrated leadership have impacted issues of health disparities in Georgia and the nation.

## Morehouse School of Medicine Facts

### STUDENTS

Student enrollment for 2009-2010 is 329. In 2009, some 3,900 students applied to the Doctor of Medicine program. Fifty-six were admitted. The Class of 2009 established an outstanding legacy: The Class achieved a 100 percent pass rate for first-time test takers on the U.S. Medical Licensing Examination (USMLE) Step 1; established an endowed scholarship for future M.D. students; and had a member complete the M.D. and Ph.D. programs simultaneously.

### RESIDENTS

- MSM has seven residency programs: Family Medicine, Public Health and Preventive Medicine, Internal Medicine, Obstetrics and Gynecology, Psychiatry, Surgery, and Pediatrics.
- Grady Memorial Hospital is the major teaching site for MSM students and residents. One of the largest public hospitals in the Southeast, Grady is internationally recognized.

### FACULTY

Morehouse School of Medicine employs more than 200 full-and part-time faculty members, many of whom are internationally recognized in their field. Among its faculty and leadership, MSM has four members elected to the prestigious Institute of Medicine.

### RESEARCH

The school's research stature and reputation have grown exponentially over the last decade. In 2009, MSM received more than \$54 million in National Institutes of Health funding. The outcomes of our research activities have resulted in the establishment of centers, institutes, and programs with our signature areas of research being cardio-metabolic diseases, cancer, HIV/AIDS, reproductive diseases and neurological disorders—all areas that disproportionately impact minority communities.
