John Davies-Cole, PhD, MPH



Dr. Davies-Cole is the Chief Epidemiologist for District of Columbia Department of Health, Washington, DC. He is also an Adjunct Professor of Global Health at the George Washington University School of Public Health in Washington, DC. He was also a World Health Organization (WHO) Fellow with extensive experience in epidemiology and disease control. He has extensive experience in global disease control and was involved in control of sleeping sickness at the International Center of Insect Physiology and Ecology (ICIPE) in Nairobi, Kenya. In his capacity as chief epidemiologist, he supervises a team of epidemiologists, data analysts and disease investigators who conduct disease surveillance activities and respond to infectious disease occurrences and outbreaks. He currently leads the Health Surveillance Branch for the District of Columbia COVID-19 emergency response.

A Physician-Epidemiologist with about 15 years' experience in clinical medicine, design and implementation of epidemiological studies, outbreak response, and analytics. Dr. O'Carroll received his medical doctorate and Master of Public Health degrees from Johns Hopkins University, and holds affiliate professor appointments in the schools of public health and medicine at the University of Washington, and at the Emory University Rollins School of Public Health.
